Classic Asset Management, LLC is registered with the Securities and Exchange Commission as an investment adviser and, as such, we provide advisory services rather than brokerage services. Brokerage and investment advisory services and fees differ and it is important for you, our client, to understand the differences. Additionally, free and simple tools are available to research firms and financial professionals at Investor.gov/CRS, which also provides educational materials about broker-dealers, investment advisers, and investing. This document is a summary of the services and fees we offer to "retail" investors, which are natural persons who seek or receive services primarily for personal, family, or household purposes.

What investment services and advice can you provide me?

We offer **Financial Planning Services and Portfolio Management Services** to retail investors: Detailed information regarding our services, fees and other disclosures can be found in our <u>Form ADV Part 2A Items 4, 7, and 8</u>

Account Monitoring: If you engage our firm for advisory services and open an investment advisory account with our firm, as part of our standard service we will monitor your investments on a daily basis.

<u>Investment Authority:</u> We manage investment accounts on a <u>discretionary</u> basis whereby <u>we will decide</u> which investments to buy or sell for your account. You may limit our discretionary authority (for example, limiting the types of securities that can be purchased or sold for your account) by providing our firm with your restrictions and guidelines in writing. We also offer <u>non-discretionary</u> investment management services whereby we will provide advice, but <u>you will ultimately decide</u> which investments to buy and sell for your account. You have an unrestricted right to decline to implement any advice provided by our firm on a non-discretionary basis.

Investment Offerings: We provide advice on various types of investments. Our services are not limited to a specific type of investment or product.

<u>Account Minimums and Requirements:</u> In general, we do not require a minimum dollar amount to open and maintain an advisory account; however, we have the right to terminate your account if it falls below a minimum size which, in our sole opinion, is too small to manage effectively.

- What is your relevant experience, including your licenses, education and other qualifications?
- · What do these qualifications mean?

What fees will I pay?

The following summarizes the principal fees and costs associated with engaging our firm for investment advisory services. For detailed information, refer to our <u>Form ADV Part 2A</u>, <u>Items 5</u>

- Asset Based Fees Payable quarterly in advance. Since the fees we receive are asset-based (i.e. based on the
 value of your account), we have an incentive to increase your account value which creates a conflict especially for
 those accounts holding illiquid or hard-to-value assets,
- Hourly Fees Payable in arrears,
- Fixed Fees Payable in arrears.

Examples of the most common fees and costs applicable to our clients are:

- · Custodian fees.
- · Account maintenance fees,
- · Fees related to mutual funds and exchange-traded funds,
- · Commissions.
- Fees related to variable annuities, including surrender charges,

- · Transaction charges when purchasing or selling securities, and
- Other product-level fees associated with your investments.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

Kev Questions to Ask Your Financial Professional

 Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- Third-Party Payments: Persons providing advice on behalf of our firm are registered representatives with a broker-dealer. These persons receive compensation in connection with the purchase and sale of securities or other investment products. Compensation earned by these persons is separate and in addition to our advisory fees. This practice presents a conflict of interest because they have an incentive to recommend investment products based on the compensation received rather than solely based on your needs.
- Third-Party Payments: Persons providing investment advice on behalf of our firm are licensed as
 independent insurance agents. These persons will earn commission-based compensation for selling insurance
 products. Insurance commissions are separate and in addition to our advisory fees. This practice presents a
 conflict of interest because they have an incentive to recommend insurance products to you for the purpose of
 generating commissions rather than solely based on your needs.
- Persons providing advice on behalf our firm are dually registered with Secure Asset Management, an affiliate of the broker-dealer mentioned above.

How might your conflicts of interest affect me, and how will you address them?

How do your financial professionals make money?

The financial professional servicing your account(s) are paid by fee for services and/or asset management fees.

Do you or your financial professionals have legal or disciplinary history?

Yes, our firm or our financial professionals currently have legal or disciplinary history to disclose. These events are disclosed in either our Form ADV or the specific individual's Form U4. These documents can be found by going to Investor.gov/CRS.
